6. The highest bidder shall be declared as winner.
7. Opening and canvassing of sealed bids shall be done on December 4, 2024 beginning 2:00 o'clock in the afternoon at the Administration Conference Room.
8. Winning bidder must pay the full amount of their bids upon receipt of the Notice of Award. Otherwise, it may be a ground for cancellation of the bid and forfeiture of the bond.
9. Awardee/s to this bidding is/are given fifteen (15) working days to haul the items awarded upon presentation of Official Receipt of full payment. Failure to withdraw in the specified period, the awardee/s shall be charged two hundred pesos (P200.00) for everyday of delay as storage fee.
